ORDER:

Government have been considering for some time past to start a few Government Degree Colleges in the State so as to create more educational facilities to the Youth in the State. Accordingly, Government hereby sanction the starting of the following New Government Degree Colleges with one section each in B.A/B.Com with effect from this academic year i.e., 1994-95:

1. Government Degree College for Women, Jagityal, Karimnagar District.
2. Government Degree College for Women, Gadwal, Mahabubnagar District.

4. Government Degree College, Bantumilli, Krishna District.
5. Government Degree College, Pithapuram, East Godavari District.
6. Government Degree College, Bhatnasa, Adilabad District.
7. Government Degree College, Vemuru, Guntur District.

2. The Commissioner of Collegiate Education, A.P. Hyderabad shall ensure that the College Committee shall fulfil conditions stipulated in G.O. Ms. No: 29, Education, dt: 5-2-1987 read with G.O. Ms. No: 208, Education, Dt: 21-8-1990 and G.O. Rt. No: 1623, Education, Dated: 12-10-90 and relating to the provisions of Corpus Fund, Land and Buildings and furniture as well as Laboratory facilities wherever applicable.

Sanction is also accorded for the following teaching and Non-teaching staff for each college sanctioned in para(1) above.

The above posts shall carry pay and allowances as admissible under rules issued from time to time.

5. The Commissioner of Collegiate Education, Hyderabad is directed to fill the teaching staff in the above Colleges by re-deployment of surplus staff from other locations.

6. Sanction is also accorded for Rs. 5.00 lakhs (rupees five lakhs only) for each college, as additional funds over and above the plan budget which shall be allotted to the Commissioner of Collegiate Education and debited to the following head of account:-

6. The above expenditure shall be met from the budget provision available under the control of Commissioner of Collegiate Education in relaxation of Treasury control orders which shall be regularised by way of reappropriation from savings or by way of Supplementary Grant before 31-3-95.


