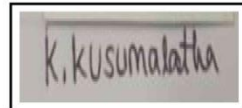

  - (5) He shall follow the job chart appended to these proceedings.
  - (6) The candidate services will be terminated without any notice, if performance is not found to be satisfactory.
  - (7) If the Certificates produced by the candidate for securing employment are found to be false, the services will be terminated besides initiating criminal proceedings against the candidate.
